Dear Dr. Bogonikolos,

As you already know "Care for the mentally disabled of Pieria", aka "Merimna Katerinis" in Greek, is a non-profit NGO that was founded in 1979 in Katerini. Its purpose is to advance the rights and well-being of disabled persons and specifically the one with mental disability.

Currently we have in operation **two facilities that provide Day Care** to the persons of the province of Pieria with mental disability. Their total capacity is 92 people with a projection of increasing this number to 140 in two years. At these facilities, among the day care, there are also programs of therapies (speech therapy, occupational therapy, physiotherapy), preparation for autonomous or semi- autonomous living, sports, leisure, psychological support etc.

Beginning December 2018 there are also in operation **three house of semi-autonomous living** where a total 12 people will be accommodated. Our goal is to expand this action and make a net of house through the province.

To these ends, your proposition for the development of the Tap2sos solution finds us supportive, since we are convinced that it will prove as an added value solution for our efforts towards the advancement of health care services to our people.
